In December of 2010, the Cook County State's Attorney Regional Organized Crime Task Force (CCROC) was created. The forged partnership led by the State's Attorney's Office brought together law enforcement and private corporations to defeat criminal enterprises and organized crime syndicates. We have lobbied and changed legislation in Illinois. We are organized in a way that makes us more effective and efficient in our investigations and prosecution.

Coalition members have access to an internet based secured data base (www.CookCountyRoc.org), that provides users with information sharing and real-time email alerts about organized retail crime, cargo thefts or financial crimes.

The private-public partnerships that we have jointly created and developed has unprecedented success, not just in the Chicago area, but in the **Midwest** and **nationally**.

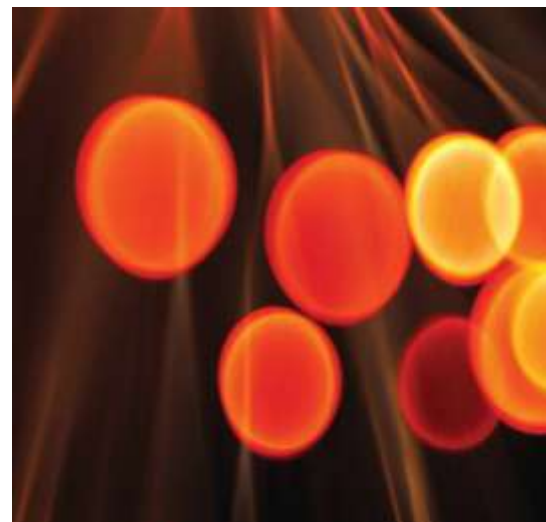
