# 11:45 <u>Lunch and Keynote Speaker</u>: *Kelby Woodard - President of Cristo Rey Dallas*College Prep

Prior to accepting the position of President of Cristo Rey Dallas College Prep in April 2014, Mr. Woodard was the co-founder of two entrepreneurial enterprises, Trade Innovations, Inc. and TRG Direct, LLC. These companies provide software and consulting solutions for importers and exporters with trade-related issues ranging from traditional regulatory compliance to the design and implementation of supply chain security and food fraud protection programs throughout the world. The formation of these entities was preceded by 11 years with retailer Target Corporation where Mr. Woodard served as the Director of Supply Chain Assets Protection. In this capacity, he designed and implemented Target's strategic global security program which spanned 84 countries and 34 U.S. distribution centers and was the second largest global retail supply chain into the U.S. With his team, Mr. Woodard was instrumental in providing supply chain security expertise to the legacy U.S. Customs Service following the attacks of September 11. The result of these consultations was the formation of the Customs-Trade Partnership Against Terrorism (C-TPAT) program, and under Mr. Woodard's leadership, his employer became one of the

seven charter members. Before joining Target, Mr. Woodard served with the U.S. Customs Service. He has given numerous presentations around the world to such diverse groups as the World Customs Organization, the Association of Metropolitan School Districts, the Retail Industry Leaders Association. and ECR Europe. Mr. Woodard holds an MBA in International Business, concentration in Latin American Studies, from the University of Dallas and a Certificate in Global Security Management from Georgetown University. A Dallas native and lifelong Catholic, he is a graduate of the University of North Texas and of Jesuit College Preparatory high school in Dallas. At the time of the Cristo Rey Dallas College Prep presidential search, Mr. Woodard was completing his second term as a citizen legislator in the Minnesota House of Representatives. There, he was Minority Lead on K-12 education issues and a champion of education reform in his state. As the chief author of the first school voucher bill to pass the House and the Senate in the state, he has been a strong advocate for the need for an innovative approach to the challenges our education system faces in serving those suffering from a persistent achievement and 'aspiration' gap compared to their peers. He earned high respect as a thought leader in education reform, and he regularly advised advocates and political groups on solutions to the urban education crisis. Having been at the forefront of education reform, he witnessed firsthand the unique power of the Cristo Rey model to transform young lives in urban America, in particular at the Cristo Rey Jesuit High School in Minneapolis. These experiences led him to fervently believe that a faith-based, college preparatory environment is the best hope for those who have been failed by more traditional approaches to education. When he learned that a Cristo Rey school was opening in Dallas, it seemed the perfect opportunity to bring together his past experience with his passion for serving those who have been left behind by our education system. It was a chance to live out the Jesuit motto 'Man for Others' as the Founding President of Cristo Rey in his hometown of Dallas.

SSA McNair has a degree in biological sciences and many of the cases conducted under the Dallas Homeland Security Investigations Office have been related to the bio-chemistry and pharmaceutical fields. After graduating college SSA McNair served in the United States Coast Guard throughout the South Florida area. SSA McNair also served as a deputy sheriff in South Florida prior to becoming a special agent with U.S. Customs under the Department of Treasury.
